

Contact Information for Filing Complaints

If an issue cannot be resolved via Tiffin University's internal processes, students taking online courses and who reside in a [“SARA” labeled state](#) may choose to file a complaint with the [Ohio Department of Higher Education](#). Students residing in states that are not participating in SARA may appeal to their state of residence.

The following chart allows students to find the contact information for each state agency that would handle the complaint. You may also contact our accrediting agency, the [Higher Learning Commission](#).

Pursuant to 34 CFR § 668.43(b) (Code of Federal Regulations), an institution of higher education must “provide students . . . with contact information for filing complaints with its accreditor and with its State approval or licensing entity and any other relevant State official or agency that would appropriately handle the student’s complaint.”
